GENERAL INFORMATION VALID FOR ANY TREATMENT

All the treatments carried out through this website are based on the principles of lawfulness, correctness and transparency.

At any time, it is possible to exercise the rights set out in the articles of law mentioned above by making an explicit request to the owner or data processor. It is also possible to request precise information about the subjects who process the data on behalf of the owner (Managers, Officers, etc ...).

During the processing operations, an adequate level of protection and confidentiality will be guaranteed and compliant with the provisions of art. 32 of the GDPR.

SPECIFIC INFORMATION FOR EVERY TYPE OF TREATMENT

a. Data collected from the use of our services by the User

Type of data processed:

- internet protocol (IP) address;
- date and time;
- type of connection (http-https);
- destination and origin url;
- browser and OS identification string;
- connection status code.

Purpose: to obtain statistical information on the use of services (most visited pages, number of visitors by time or day, geographical areas of origin, etc.); check the correct functioning of the services offered.

This is information that is not collected to be associated with identified data subjects, but which by their very nature could, through processing and association with data held by third parties, allow users to be identified.

The data could be used to ascertain responsibility in case of hypothetical computer crimes against the site.

Legal basis: Article 6 letter f) GDPR: the processing is necessary for the pursuit of the legitimate interest of the data controller or third parties, provided that the interests or fundamental rights and freedoms of the data subject that require the protection of personal data, in particular if the data subject is a minor.

Retention times: the navigation data do not persist for more than seven days and are deleted immediately after their aggregation (except for any need to ascertain crimes by the judicial authorities).

Nature of the provision: mandatory to take advantage of the website's functions.

b. Data provided by the user through the use of the site's features:

Type of data processed: personal contact data.

Purpose: management of requests for information received from visitors by filling in the electronic forms on the pages of the site, or through the email addresses of the offices and / or staff.

Legal basis: art. 6 lett. b) GDPR the processing is necessary for the execution of a contract of which the interested party is a party or for the execution of pre-contractual measures adopted at the request of the same.

Nature of the provision: the provision of data is necessary in order to respond fully and correctly to requests.

Retention times: the data will be kept for periods compatible with the purpose of the collection and subsequently deleted. The data may be disclosed to third parties only when it is functional to give correct feedback to the interested party.

THE SUBJECTS TO WHOM THE DATA MAY BE COMMUNICATED

Where necessary, the communication of the data will eventually be made only to competent authorities, trusted subjects appointed by the Website Owner for the performance of technical and / or organizational tasks (provision of legal, accounting, tax, consultancy services, etc. .). Your data may be disclosed to partner companies appointed as external data processors pursuant to art. 28 of EU Reg. 2016/679 to follow up on your requests.

Personal data are not subject to disclosure or transfer of data outside the EU.

RIGHTS OF THE INTERESTED PARTY

The interested parties have the right to obtain from the Data Controller, in the cases provided for, access to personal data and the correction or cancellation of the same or the limitation of the processing that concerns them or to oppose the processing (articles 15 et seq. of the Regulation).

Interested parties who believe that the processing of their personal data carried out through this service is in violation of the provisions of the Regulation have the right to lodge a complaint with the Guarantor, as required by art. 77 of the Regulation itself.

LOG AND COOKIES

The site uses only temporary cookies. Furthermore, some information is automatically collected during the visit and navigation of the pages of the Site (type of browser used, time of connection, IP addresses, already ISP, etc.) and stored in the log.
