Purpose and legal basis of the processing

The data of the interested party will be processed by Castiglioni Valves s.r.l. for the following purposes: to provide services and performances for the correct and complete execution of the assignment received (effective management of relationships between the parties, management of the existing contract, management of the services provided and/or management of existing commercial relationships in the exchange of goods and/or products and/or services, management of invoicing and related accounting and/or tax obligations). Any management of litigation (debt collection activities, failure to perform existing services, legal disputes, transactions). The legal basis of the processing for these purposes is based on precontractual and/or contractual needs to which the interested party is a party and on the fulfillment of legal obligations to which the Data Controller is subject (art. 6 par.1 lett.b,c).

The processing of your data will be based on the principles of correctness, lawfulness and transparency and can be carried out with or without the aid of electronic processes in compliance with the security measures designed to guarantee the confidentiality of the data processed.

Categories of personal data processed

Personal data categorized as personal and contact details.

Recipients or possible categories of recipients of personal data

For the pursuit of the purposes indicated above, the data may be processed by persons authorized by the Data Controller and/or persons identified as independent Data Controllers or external Data Processors. In particular, the data may be communicated to: legal and/or professional firms that provide the Data Controller with certain services; public bodies; insurance companies; competent authorities; banks and/or credit institutions; supervisory bodies and any other person to whom communication is mandatory by law.

Duration of processing

For the pursuit of the purposes indicated in this information notice, the data will be retained for the entire duration of the contract and in any case no longer than the achievement of the purposes for which they are collected and processed and in compliance with the provisions of the law (10 years pursuant to art. 2220 of the Italian Civil Code or different legal obligation). Data potentially processable in the event of litigation will be retained until the end of any litigation.

Transfer of data abroad

The personal data collected will be processed within the European Union, they may be transferred to countries outside the European Union, provided that an adequate level of protection is guaranteed, recognized by a specific adequacy decision of the European Commission. (Art. 45 par.2 Reg. UE 2016/679). Any transfers of Personal Data to non-EU countries, in the absence of an adequacy decision of the European Commission, will be possible only if adequate security guarantees are provided by the Data Controllers and Processors involved (arts.46,47 Reg.UE 2016/679). The transfer of personal Data to third countries outside the European Union, in the absence of an adequacy decision or other adequate measures as described above, will be carried out only in the presence of explicit consent from the interested parties or when one of the conditions referred to in art. 49 Reg.UE 2016/679 occurs.

Rights of the interested party

The interested party is recognized with the following rights: access to the personal data processed (art. 15), rectification (art. 16), erasure (art. 17), limitation of processing (art. 18), opposition to processing (art. 21), where applicable the right to data portability (art. 20).
